

### **WARRANTY**

hankyou for selecting Enviroguard window and millwork products from Precision Millworks, Inc. These products will provide you with value and peace of mind for years to come. Please read the following warranty information carefully, as there are certain limitations and disclaimers—as there are in all warranties—that must be included to insure that all parties understand how the product is to be installed and used.

#### 20-25 Warranty

Precision Millworks, Inc., warrants our insulated glass against seal failure for 20 years. All cellular PVC components are warranted for 25 years.

#### Precision Insulated Glass In Enviroguard Windows 20-Year Warranty

Under normal conditions, Precision warrants their insulated glass against seal failure and the resulting visual obstruction. If seal failure occurs, Precision will provide replacement insulated glass only in the 20-year period. Replacement glass will be shipped FOB factory. Removal, installation, refinishing, and disposal are NOT covered by this warranty.

# Cellular PVC Components 25-Year Warranty

While similar in appearance to wood, the cellular PVC components in the Precision Enviroguard Window is far superior and therefore carries a 25-year warranty against rot and corrosion. If replacement or repair is necessary during the warranty period, such replacement and/or repair

will be warranted for the remainder of the original warranty period.

### Painting of Cellular PVC Windows

Enviroguard should be painted with oil base or latex paint using industry standard painting techniques after cleaning.

Enviroguard product extrusions are cellular PVC, a vinyl-based composite. As such, they may be subject to thermal expansion and contraction at direct temperatures above 145 F degrees. Extreme dark colors may accelerate this situation, as dark colors tend to absorb a greater amount of solar heat, which can cause cellular PVC to expand and contract excessively and warping/ distortion can occur. Distortion of frame and sash components, paint adhesion loss, blistering and peeling could also result. Painting Enviroguard products a dark color (any color that falls within the L value of 56 to 0) can generate high localized temperatures in the product.

WARNING: Painting any Enviroguard cellular PVC product with a paint color darker than L value of 56 (where black = 0 and white = 100 will forfeit the product warranty.

If, despite the above warning, you should choose to paint Enviroguard products a dark color (as defined above), a paint specifically designed for these applications MUST be used. Whichever paint manufacturer is chosen must be contacted to verify the paint's reflective properties and suitability with regard to painting cellular PVC. Precision Millworks Inc is not liable for paint used on our cellular PVC components or the result of its use.

#### **Wood Components**

All exterior wood components of the Precision Enviroguard Window are warranted for a period of one year.

All interior wood components are warranted a period of three years. Yearly inspection of paint and caulking and correction of any deterioration of such will protect all wood components from exposure.

## Other Parts And Components 10–Year Warranty

Precision purchases certain parts and components of the Enviroguard Series from other manufacturers. These include but are not limited to hardware components and weather-strips. Should these parts or components sustain failure that substantially impairs the operation of a product, Precision will provide replacement at no charge for a period of 10 years.

Precision will make every effort to provide the same model as the original; that may, however, not always be possible, as we buy from the manufacturers of these components and the model in question may not be available. Any part, component, or product repair or replacement is warranted for the remainder of the original warranty period. Precision's warranty does not cover any cost of removal, installation, refinishing, disposal, or delivery/freight.

### Field Modification Of Enviroguard Windows

Any field modification, such as removal of



brickmould or exterior casing voids the warranty.

#### **Warranty Claims Procedure**

The warranties included herein are in lieu of all other warranties, expressed or implied, including any implied warranties of merchantability or fitness for any particular purpose.

Supplying replacement parts or making repairs under this warranty shall not extend the warranty time period of the warranty on the originally purchased unit(s).

No employee, dealer, distributor, salesperson, or representative of Precision Millworks, Inc., has the authority to alter or modify this warranty in any way, whether written or oral.

Precision Millworks, Inc., is not liable for any cost associated

with removal, installation, refinishing, staining, or disposal

of replacement units. Precisions Millworks, Inc., is not liable for any consequential, incidental, or punitive damages. The remedies set forth in this warranty are exclusive and the liability of Precision Millworks, Inc., from the manufacture, sale, delivery, resale, installation or use of any products(s) furnished to the customer, whether by contract, negligence, strict tort, or under any warranty or otherwise, shall not, unless expressly provided for in Precision Millworks' Warranty Policy, exceed the price of the product(s) upon which such liability is based.

This warranty is governed by the laws of the state of Georgia without regard to choice of law principles. If any portion or provision of this warranty is found to be unenforceable, all remaining provisions shall remain in full force and effect.

### **REMEDIES** Certain components and/or unit(s) will be forfeited by certain actions or conditions, like the following:

Improper installation of the product. All installation instructions are attached to the unit(s).

Any damage that result from abuse, accident, or misapplication.

Sloped or non-vertical installation or application.

Use of any film, UV-limiting or sun-blocking to either surface of the glass.

Exposure to certain chemicals, including, but not limited to, brick wash or muriatic acid, sodium hydroxide and other alkaline, and benzene.

Damage resulting from security system attached or adhered to unit(s).

Installation in or around an area containing a spa, swimming pool, sauna, or greenhouse.

Installation in a camper, trailer, houseboat, or ship.

### $\textbf{SPECIFIC EXCLUSIONS} \ \ \textbf{The following are excluded from any remedy provided in this warranty:}$

Catastrophic Weather Conditions or Acts of God, including wind or wind blown-objects.

Units that have a "Block Size" (W x H) of 35 square feet or more. These products are sold "As is" and carry no warranty.

Custom items that are built to the customer's specifications and are specified by Precision on order confirmation as "No Warranty".

Consequential, incidental or punitive damages arising from any warranty claim, replacement, repair, or refund.

Cost of removal or replacement of defective parts, glass, product, painting, refinishing, or disposal.

Damages from heat reflection from glass resulting in heat gain or vinyl distortion.

Damages resulting from handling or delivery by others.

Damages resulting from improper installation or maintenance.

Damages or stress to product brought on by building defects, settling or movement of structure.

Loss of inert gases due to normal dissipation. Gases dissipate over time at different rates due to climate, use, and conditions.

Claims for glass breakage, including stress cracks after installation.

Normal wear and tear, including weathering.
